Article II - Preamble

This humaniterian Non-Profit organization was founded on December 24th, 2014 by Mr. Frank White, a citizen of the United States of America, and properly recorded in Florida by the Secretary of State.

Article V - Purpose

Said national Non-Profit Foundation is created, organized and managed exclusively for charitable, educational and scientific purposes to Save Life and to prevent Loss of Lives on the water, in the air and over land and to prepare, respond and recover from natural and unexpected disasters by serving our communities, through speedy emergency assistance and by utilizing, organizing and managing the available, related, non-monetary resources of the United States Department of Homeland Security (DHS), of the United States Coast Guard (USCG), their Auxiliary's (USCGAUX) Flotillas and Auxiliarists, of the Federal Emergency Management Agency (FEMA), of the United States Air Force (USAF), its Auxiliary's Civil Air Patrol (CAP) with search and rescue, disaster relief and radio communications recourses in the air and on the ground, private entities, other non-governmental organizations, territorial, tribal, local, state and federal government agencies, departments and commissions responsible for public safety and security, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

Article VI - Mission

The missions of this national Non-Profit Foundation is to Save Life, prevent Loss of Lives, prepare for and recover from disasters by serving our communities, through speedy emergency assistance, educational classes, seminars, workshops, exercises and trainings on the water, in the air and over land and by providing printed and electronic information and online services, as they are made available and possible through generous contributions from its founding, basic, supporting and volunteering members, fund-raisings, tax-deductable donations and grants from governmental organizations, support from private entities and non-governmental organizations by providing search and rescue, radio communication, vessel, aircraft, vehicle facilities, gasoline, food and rooms for short timed classes.

Article VII - Vision

To create, instruct and train other charitable foundation branches, dedicated to Save Life, prevent Loss of Lives, prepare for and protect against disasters within the United States of America and through affiliates around the world.

Article VIII - Appointment

The manner, in which officers and/or directors are appointed and/or elected, rests with its Founder Mr. Frank White, and if he is incapacitated, with its Vice President, and if he is unavailable, with its Trustee in accord to the bylaws.

Article XII - Operation

No part of the net earnings of this Non-Profit Foundation shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, expect that this non-profit foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of this non-profit Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of this articles, this non-profit foundation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding sections of any future federal tax code.

Article XIII - Dissolution

Upon the dissolution this Non-Profit Foundation assets shall be distributed to one or more United States Coast Guard Auxiliary's local Flotillas, or to one or more Civil Air Patrol's (CAP) local Squadrons, or for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of this non-profit foundation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determined, which are organized and operated exclusively for such purpose.
