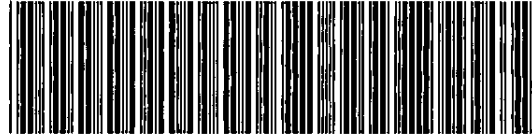

### **DISSOLUTION**

If no such designation is made, then the property of the corporation shall be distributed to Antioch Fellowship Baptist Church, Nature Coast Baptist Association of the Florida Baptist Convention provided it shall then qualify under §501(c)(3) of the Code, or if Nature Coast Baptist Association. or its successor does not so qualify then to such organization of like faith as shall qualify under §501(c)(3) of the Code, as directed by a Justice of the Supreme Court of Florida.
