**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
LAKE HIGHLAND YOUTH SPORTS ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, Lake Highland Youth Sports Association, Inc., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Lake Highland Youth Sports Association, Inc.
2. The original Articles of Incorporation for the Corporation were filed on February 11, 2015, and assigned Document No. N15000001460.
3. By the execution of a written consent executed on February 3rd, 2017, the Corporation's board of directors have approved, authorized, and directed that Article I of the Corporation's Articles of Incorporation be amended and restated. There are no members entitled to vote on the amendment, and the amendment was adopted by the board of directors.
4. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

**ARTICLE I - NAME OF CORPORATION,
THE MAILING ADDRESS AND THE PRINCIPAL OFFICE ADDRESS.**

The name of the Corporation shall be **EDGEWATER YOUTH SPORTS ASSOCIATION, INC.** The mailing address and the principal office address of the Corporation shall be 3295 Hiwassee Road, Suite 203, Orlando, Florida 32835.
