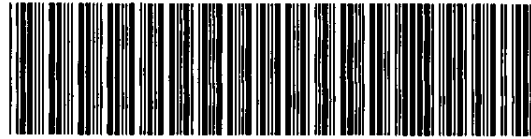

Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of this corporation shall be: **Soroptimist International of Homestead, Inc.**

Article II Principal Office

Article III Purpose

The purpose for which this corporation is organized is: **Soroptimist International of Homestead, Inc.** club was formed exclusively for charitable, scientific, literary, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law (the "Code"), particularly to:

- a. We promote the advancement of women through volunteer service to the community;
- b. We serve as a global voice on issues of importance to women; and
- c. We engage in any other lawful activities that further the exempt purpose of the Club.

No part of the net earnings of Soroptimist International of Homestead, Inc. shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the Club shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes. Except as otherwise provided by Section 501(h) of the Code, no substantial part of the activities of our Club shall consist of carrying on propaganda, or otherwise attempting, to influence legislation. The Club shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of these articles, the Club shall carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under

Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code, or (b) by an organization contributions to which are deductible under Section 170(a) of the Code as being to an organization referred to in Section 170(c)(2) of the Code.

Soroptimist International of Homestead, Inc. shall be nonprofit, noncommercial, nonsectarian, and nonpolitical.

Dissolution: Upon the dissolution of this Club, its governing body shall, after paying or making provisions for the payment of all of the liabilities of the Club, dispose of all the assets of the Club exclusively for the exempt purposes of the Club in such manner, or to such organization or organizations organized and operated exclusively for charitable, scientific, literary, or educational purposes which at the time qualify as exempt organization or organizations under Section 501(c)(3) of the Code, as the Club's governing body shall determine. Any assets not so distributed shall be distributed by a court of competent jurisdiction of the county in which the Club's principal office is then located exclusively for the Club's exempt purposes. The use of any surplus funds for private inurement to any person in the event of a sale of the assets or dissolution of the corporation is expressly prohibited.






