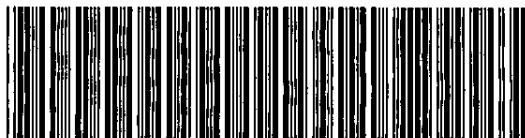

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporate Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: The name of the corporation is **Human Rights Journal, Inc.**

ARTICLE II: The principal place of business and mailing address of this corporation shall be at 1401 West Flagler Street, Suite 101, Miami, Florida 33135-2208.

ARTICLE III: The specific purposes for which this corporation is organized are:

This corporation is charitable organized exclusively for one or more purposes as specified in Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Specific Objectives and Purposes

The specific objectives and purposes of this corporation shall be:

This is a charitable organization exclusively for one or more purposes as specified in Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

The objective of the organization is to ensure federal and state prisons comply with the recommendations of the American Bar Association (ABA) Criminal Justice Standards on Treatment of Prisoners approved by ABA House of Delegates, February 2010. Specifically, the organization will monitor compliance with those recommendations made for the humane treatment of prisoners¹, and the rights of prisoners in accordance with the American Civil Liberties Union.²

The activity will be accomplished via freedom of information request, the credentialing of staff as journalists and invocation of the First Amendment of the United States Constitution to interview present and former-prisoners for indications of abuse that may be lead to investigated in concert with pertinent authorities and the media.

Furthermore, this organization monitors and reports on the recommendations and resolutions of the Office of the United Nations High Commissioner for Human Rights (OHCHR) "Basic Principles for the Treatment of Prisoners," as adopted and proclaimed by General Assembly resolution 45/111 of 14 December 1990.

The foregoing activity will be accomplished via freedom of information requests, the credentialing of staff as journalists and invocation of the First Amendment of the United States Constitution to interview present and former-prisoners for indications of abuse that may be lead to investigated in concert with pertinent authorities and the media.

As an integral part of its program, this corporation will implement a secure web site to receive donations, disseminate its messages, receive anonymous complaints from victims, their families, and witnesses to first validated the information and develop indicators sufficient to justify formal investigations. Staff will also proactively scan social media for leads.

This corporation does not discriminate on the basis of race, gender, colour, sexual orientation, ethnicity, religion, or disability.

This corporation does not discrimination on the basis of race, gender, national origin, colour, sexual orientation, ethnicity, religion, or disability.

ARTICLE IV: The manner in which the directors are elected or appointed is:

Initially, four shall be the following four directors.

President, Mr. Anselmo L. Alliegro, 1401 West Flagler Street, Suite 101, Miami, Florida 33135.

Vice President, Luciano Garcia, 1401 West Flagler Street, Suite 101, Miami, Florida 33135.

Treasurer, Pasquale Diaz, 1401 West Flagler Street, Suite 101, Miami, Florida 33135.

Secretary, Marcelino Rodriguez, 1401 West Flagler Street, Suite 101, Miami, Florida 33135.

Directors shall serve on staggered terms basis. One director shall serve for a one-year term, two directors for a two-year term, and another two directors for a three-year term. The initial directors where selected according to Bylaws from among distinguish members of the community. At end of each term, directors will be elected according to Bylaws.

ARTICLE V: The name and address of the initial registered agent is:

ARTICLE VI: The name and address of the Incorporator of these Articles of Incorporation is: Mr. Anselmo L. Alliegro, 1401 West Flagler Street, Suite 101, Miami, Florida 33135.

ARTICLE VII: The period of duration of this corporation is perpetual.

ARTICLE VIII: The classes, rights, privileges, qualifications, and obligations of members of this corporation shall be stated in the bylaws of this corporation.

ARTICLE IX: Additional provisions for the operation of the corporation are as follows:

1. Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
2. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. No part of the net earnings of this corporation shall inure to the benefit of, or be distributed to, its members, directors, officers, or other private person, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
4. Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
5. In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation (1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; and; (2) shall not engage in any act of self-dealing as defined in Section 4941(d) of Internal Revenue Code; (3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; (4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and, (5) shall not make any taxable expenditure as defined in Section 4945(d) of the Internal Revenue Code.
