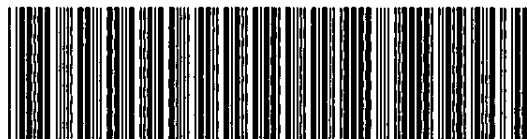

Articles of Incorporation of Midway Missionary Baptist Church

Article I – Name

The name of this corporation shall be

Midway Missionary Baptist Church, Inc.

Article II - Principal Office- Mailing and Physical address.

The corporation shall be located at 12813 Bay Lake Rd. Groveland Florida

Article III- Purpose

The purpose of this corporation is to conduct for religious worship and instruction churches, schools, pastoriums and other institutions connected there with of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith which are most surely held among Baptist Churches and to advance the spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the vicinity in which it is located, to promote home and foreign missions; and to aid in the spread of the Gospel of Jesus Christ to the ends of the earth; also to educate, prepare, and ordain Christian men for the ministry of the Gospel of Jesus Christ.

Article IV- Manner of Election

The business of the corporation shall be managed by a Board of Trustees, such management is to be subject to the approval of the church, and said Board is to be composed of three members. The number of Trustees may be increased by the by-laws of the corporation not to exceed nine in number. The term of the membership of said Trustees shall be for one year and or their successors have been elected and have qualified. No person shall be an officer of the corporation who is not a member of the corporation.

The said Board of Trustees shall appoint from its own membership a Chairman, Vice Chairman and Secretary. All legal instruments of the corporation shall be signed by said Chairman, or Vice Chairman and attested by said secretary; or in such other manner as may be authorized by law. All elections to membership on said Board of Trustees shall be by majority vote of the members of said corporation present and voting at any regular business meeting of the said corporation.

In addition to the said Board of Trustees said corporation shall have a pastor, a Church Clerk,, a treasurer, a Sunday school superintendent and such other officers as may be necessary, and such officers shall be elected by majority vote of the members of the corporation present at any business meeting of the said corporation for such term as the corporation may provide by its by-laws.
