

Articles of Incorporation of Midway Missionary Baptist Church

Article 1 - Name

The name of this corporation shall be Midway Missionary Baptist Church, Inc.

Article II - Principal Office- Mailing and Physical address.

The corporation shall be located at 12813 Bay Lake Rd. Groveland Florida

Article III- Purpose

The purpose of this corporation is to conduct for religious worship and instruction churches, schools, pastoriums and other institutions connected there with of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith which are most surely held among Baptist Churches and to advance the spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the vicinity in which it is located to promote home and foreign missions; and to aid in the spread of the Gospel of Jastis Chieft to the ends of the earth; also to educate, prepare, and ordain Christian men for the ministry of the Gospel of Jesus Christ.
