Articles of Incorporation

The undersigned incorporator(s), a natural person 18 years of age or older, in order to form a corporate entity adopts the following articles of incorporation.

ARTICLE I

NAME/REGISTERED OFFICE & PRINCIPAL ADDRESS

The name of this corporation shall be Red Democratica Internacional Inc., located at:

ARTICLE II

PURPOSE

This corporation is organized exclusively for charitable and educational purposes more specifically it is dedicated to (1) promote democracy and peace as tools of development for a safe and progressive Venezuela; (2) Social Responsibility, promotes as basis for all societies (3) develop alliances that include corporations, institutions, and private citizens of Venezuela and the world.

To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. corporation affecting one or more of its purposes. Such net earnings, if any, of this corporation shall be used to carry out the nonprofit corporate purposes set forth in Article II above.

- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
