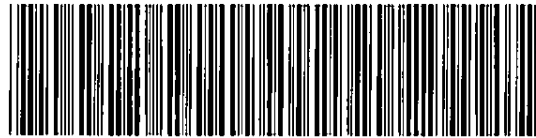

FIRST ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION FOR
CIPRIANI AT LELY RESORT CONDOMINIUM ASSOCIATION, INC.

These First Articles of Amendment ("**Amendment**") to the Articles of Incorporation of Cipriani at Lely Resort Condominium Association, Inc., a Florida not-for-profit corporation ("**Association**"), are adopted effective as of this 11th day of October, 2017 ("**Effective Date**").

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following amendments to its Articles of Incorporation effective as of the Effective Date hereof, as follows:

1. RESOLVED, that Article I of the Articles of Incorporation filed with the Secretary of State of Florida (Document Number N15000001752) be amended and restated in its entirety, as hereinafter set forth:

"ARTICLE I
NAME AND ADDRESS

The name of the corporation, herein called the "Association", is Tasori at Lely Resort Condominium Association, Inc. The address of the Association is c/o Sandcastle Community Management, 9150 Galleria Court, Suite 201, Naples, FL 34109."

In connection with the above resolution, any and all references in the Articles of Incorporation of the Association to "Cipriani at Lely Resort Condominium Association, Inc." shall be amended and restated to be "Tasori at Lely Resort Condominium Association, Inc."

2. RESOLVED, that any and all references in the Articles of Incorporation of the Association to "Cipriani at Lely Resort, a Condominium" shall be amended and restated to be "Tasori at Lely Resort, a Condominium".

EXCEPT AS AMENDED HEREBY, the Articles of the Association shall remain unchanged and in full force and effect.

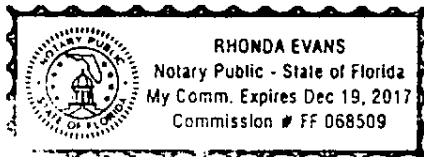
