Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Ocean Floor Web & Graphic Design Ministries is a non-profit Christian ministry focused on serving churches, small businesses, organizations, and other specific groups in need of web and/or graphic design. Our goal is simple — to provide you with professional grade designs without depleting the funds of your ministry or business.
