THIS CERTIFICATE OF THIRD AMENDMENT TO THE BY-LAWS OF RAINTREE AT MAYFAIR HOMEOWNERS ASSOCIATION, INC., and FIRST AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF RAINTREE AT MAYFAIR HOMEOWNERS ASSOCIATION, INC. is executed this <u>14th</u> day of <u>NOVEMBER</u>, <u>2022</u>, by RAINTREE AT MAYFAIR HOMEOWNERS ASSOCIATION, INC., a Florida Not For Profit Corporation (hereinafter referred to as the "Association").

RECITALS

WHEREAS, the Association has been established for the operation of Raintree, in accordance with the Master Declaration of Covenants. Restrictions, and Easements for Raintree, recorded December 3, 2015, as Instrument # 113381586, of the Public Records of Broward County, Florida, and all exhibits thereto ("Master Covenants"); and

WHEREAS, the By-Laws of Raintree at Mayfair Homeowners Association, Inc., were originally recorded as an exhibit to the Master Covenants and were subsequently amended pursuant to that certain Amendment to By-Laws of Raintree at Mayfair Homeowners Association, Inc., recorded on August 30, 2019, Instrument # 116025265, and that certain Amendment to By-Laws of Raintree at Mayfair Homeowners Association, Inc., recorded on October 30, 2019, Instrument # 116145397, all of the Public Records of Broward County, Florida ("By-Laws"); and

WHEREAS, the Amended and Restated Articles of Incorporation of Raintree at Mayfair Homeowners Association, Inc., were originally recorded as an exhibit to the Master Covenants ("Articles of Incorporation"); Canada

WHEREAS, certain amendments to Article 7 and Article 10 of the Articles of Incorporation and Article 4 and Article 6 of the By-Laws were proposed and approved by the Board of Directors of the Association; and

10. <u>Board of Directors</u>. The affairs of the Master Association shall be managed by a Board of-odd number with not less than three (3) nor more than (5) members. The current number of directors shall be three (3) Board members and <u>shall be elected</u> have been appointed as stated in the By-Laws. The election of Directors by Members other than Developer shall initially be held on the date the Developer no longer has the legal right pursuant to the Master Declaration to appoint Directors, and thereafter at the Annual Members Meeting. Directors shall be elected for a term expiring on the date of the next Annual Meeting. The names and address of the current members of the Board, who shall hold office until their successors are appointed or elected or otherwise removed are as follows:

7. <u>Powers of the Master Association</u>.

7.10 To adopt, publish, promulgate or enforce rules and regulations, covenants, restrictions or agreements governing the Master Association, Raintree, and the Common Areas, specifical Neighborhoods and Homes as provided in the Master Declaration, and to effectuate all of the purposes for which the Master Association is organized.

4.5 <u>Appointment and Election of Directors</u>. Until the Turnover Date, Developer shall have the unrestricted power to appoint all Directors of the Master Association. From and after the Turnover Date (or such earlier date determined by Developer in its sole and absolute discretion), the Members shall elect all Directors of the Master Association at or in conjunction with the Annual Members Meeting in accordance with the terms of these By-laws.

4.6 <u>Election</u>. Election to the Board shall be by secret written ballot₃₇ unless unanimously waived by all Members present. The person(s) receiving the largest number of votes in accordance with these <u>By-laws</u> shall be elected. Cumulative voting is not permitted. <u>There shall be no quorum requirement for</u> the Election, however, at least twenty percent (20%) of the Members must participate with at least ten percent (10%) representation from each Neighborhood Association. As a result, there must be at least <u>31 Members participating in the Election from The Townhomes at Raintree and 20 Members</u> participating in the Election from The Single Family Residences at Raintree in order for the Election of the Board of Directors to be held. In the event that the foregoing participation requirement is not achieved, the current individual seated in the Director seat up for election will serve again in accordance with term length as stated in Section 4.2 of these By-laws. For the Election, the below procedures will be followed:

- a. If the Townhomes Seat is up for Election and:
 - i. <u>There are no candidates from The Townhomes at Raintree, then the existing</u> <u>Director in the Townhomes Seat will serve for an additional two (2) year term.</u>
 - ii. <u>There is only one (1) candidate from The Townhomes at Raintree, then such</u> individual will be seated in the Townhomes Seat and shall serve a two (2) year term.
 - iii. <u>There is more than one (1) candidate from The Townhomes at Raintree, then the highest vote getter from The Townhomes at Raintree will be seated in the Townhomes Seat and shall serve a two (2) year term.</u>
- b. If the Residences Seat is up for Election and:
 - i. <u>There are no candidates from The Single Family Residences at Raintree, then the</u> <u>existing Director in the Residences Seat will serve for an additional two (2) year</u> <u>term.</u>
 - ii. <u>There is only one (1) candidate from The Single Family Residences at Raintree, then</u> such individual will be seated in the Residences Seat and shall serve a two:[2].year term.
 - iii. <u>There is more than one (1) candidate from The Single Family Residences at Raintree, then the highest vote getter from The Single Family Residences at Raintree will be seated in the Residences Seat and shall serve a two (2) year term.</u>
- c. <u>At Large Seat:</u>

- i. <u>If there are no candidates, the existing Director in the At Large Seat will serve for an</u> additional one (1) year term.
- ii. If the Townhomes Seat and Residences Seat are either not up for Election or have already been filled, and there is only one (1) candidate, whether from The Townhomes at Raintree or The Single Family Residences at Raintree, then such individual will be seated in the At Large Seat and shall serve a one (1) year term.
- iii. If the Townhomes Seat and Residences Seat are either not up for Election or have already been filed, and there is more than one (1) candidate remaining, whether
