ARTICLE I NAME

ARTICLE II PRINCIPAL OFFICE

<u>ARTICLE III PURPOSE</u>

The purpose for which the corporation is organized is:

Inmates USA Foundation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

A National Resource Information and Service Foundation for Inmates, Convicts or Ex-Offenders who desire to change their lives upon their release from County Jail, State Prison or Federal Incarceration.
