Courage To Believe International is a non-profit organization that provides mentoring, educational, enrichment and scholarship programs for at-risk youths and young adults in South Florida communities between the ages of 12 to 21 years. We provide comprehensive preventative and intervention programs and services that are designed to successfully create positive changes in the lives of our participants in the urban communities. Our programs are offered during/after school hours, and on the weekends at community centers. Our passion is to encourage and to inspire teenagers and young adults through our creative programs.

**Vision Statement:** To inspire and encourage urban youth and young adults from every race, color, ethnicity and nationality to believe in themselves. We aim to direct their energy into positive activities that will help them accomplish their life goals and dreams. Since 2012, we've been mentoring at-risk youth at community centers, local middle school and high schools. We offer career planning, interactive life skill workshops, and cultural field trips. In the past two years we've hosted the Annual Black On Black Crime Solutions Panel. Courage To Believe International also has a chess club entitled, *C2B Chess Club*, which teaches chess playing strategies and uses real life examples that will show the students to become critical thinkers and strategic decision makers. The knowledge of playing chess improves academic performance, concentration, logical thinking, judgment, creativity, problem solving, emotional intelligence, and social skills.

**Mission Statement:** To encourage all male and female youths and young adults in South Florida to care for their homes, communities and themselves. Our goal is to help them to appreciate and to develop a deep understanding of their history, cultures, and responsibility. We believe that this is the solution to reducing the recidivism rate and to circumvent the school-to-prison pipeline. We offer a variety of preventative programs and enrichment activities that are designed to build self-esteem, critical consciousness, character, and leadership skills in our participants. Our primary focus is to bring male and females together in an environment that encourages love, entrepreneurship, better decision making, and to develop overall positive and healthy relationships. As a result of our efforts we aim to rebuild broken homes and to save 50 youths from going to jail or prison, per year.
