ÁRTICLES OF INCORPORATION OF

TRANSFORMATION PRAYER MINISTRY INTERNATIONAL INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation is TRANSFORMATION PRAYER SMINISTRY INTERNATIONAL INC.
- 2. The principal street address of the principal office and place of business is:

- 3.
