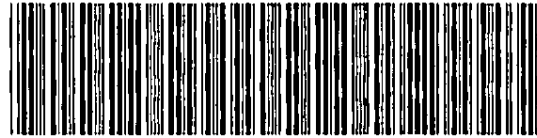

## **Palm Beach Foster Dog Project**

### **Article III Amendment**

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. The corporation is organized exclusively for charitable, religious, educational, research and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

B. The general purposes for which this corporation is organized are, within the meaning of section 501 (c) (3) of the Internal Revenue Code, is to support homeless dogs through promoting fostering, rescue and adoption through our local open-admission shelter.

C. The corporation shall also enjoy all rights and powers conferred by the laws of the State of Florida upon non-profit corporations. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, as amended, or the corresponding provision of any future United States Internal Revenue law.

D. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
