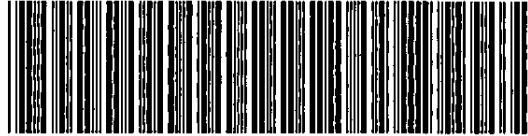

ARTICLES OF INCOPORATION

The undersigned incorporator, for the purpose of forming a corporation in compliance with Chapter 617, F.S., (Not for Profit), hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be The Red Hills Spaniel Club, Inc., a non-profit organization.

ARTICLE II

The principal place of business and mailing address of the Corporation shall be 3060 Horseshoe Plantation Road, Tallahassee, Florida 32312.

ARTICLE II

The specific purposes for which the Corporation is organized are as follows:

1. To conserve, protect, preserve and foster the survival and flourishing of the native Bobwhite Quail population in the Red Hills area of North Florida.
2. To control, manage and restrict the growth of the population of wild quail predators in the Red Hills area of North Florida.
3. To conserve, protect, preserve and foster the natural habitats most favorable to the native Bobwhite Quail in the Red Hills area of North Florida.
4. To promote and preserve the sport of hunting native Bobwhite Quail with dogs of the spaniel breeds in the Red Hills area of North Florida.
5. To support the study and research vital to the survival of the native Bobwhite Quail in the Red Hills area of North Florida including specifically the reporting to conservation organizations and The Florida Game and Fish Commission on documented finds of wild, native Bobwhite Quail in the Red Hills Area of North Florida and trends in the growth/decline of its population.

ARTICLE IV

The Corporation shall have three directors initially and thereafter from 3 to 11 directors serving annual terms of one year each, the number to be determined annually by the then expiring Board of Directors by simple majority vote. The number of Directors shall always be an odd number. Directors shall be elected by the dues-paying members of this not-for-profit corporation at its annual meeting to be held on the fourth Saturday in March of each year. A director shall be deemed elected who receives a simple majority of the votes actually cast by the dues-paying members actually present and voting at any annual meeting.

ARTICLE VI




ARTICLE VII

The corporation shall have no capital stock and is not organized for profit and no part of its net earnings shall inure to the benefit of any member or individual; and no member, director, officer, or employee of the corporation shall receive or be lawfully entitled to receive any profit of any kind from the operation thereof except reasonable compensation for services actually rendered in effecting one or more of its purposes and no substantial part of the activities of the corporation shall be to carry on propaganda or otherwise to attempt to influence legislation.

ARTICLE VIII

In the event of the dissolution and liquidation of the corporation, none of its property or funds shall inure to the benefit of any member or individual but shall be transferred and paid over to some organization designated by the Board of Directors, and which shall qualify as a corporation, association, fund or foundation organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes, or for the prevention of cruelty to animals, and no part of the net earnings of which shall inure to the benefit of any private shareholder or individual and no substantial part of the activity of which is to carry on propaganda or otherwise attempt to influence legislation.
