A MOTHER'S SECOND CHANCE, INC

ARTICLE I NAME

1.01 Name

The name of this corporation shall be A MOTHER'S SECOND CHANCE, INC The business of the corporation may be conducted as A MOTHER'S SECOND CHANCE, INC.

ARTICLE II PURPOSES AND POWERS

2.01 Purpose

A MOTHER'S SECOND CHANCE, INC is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

The purpose of A MOTHER'S SECOND CHANCE, INC. is to bring awareness and open arms to mothers in our community and around the world. Through donations A Mother's Second Chance will be Providing an 18 month full time transitional home living arrangement for single mother's and their children to live in. Scholarships will be given to these single mothers through the donations received by A Mother's Second Chance, for the mother to enter accredited beauty schools in Palm Beach County. Once completion of beauty school and state license is received, single mothers are then directed to employment opportunities through local jobs listings on social media, in the school they are attending and through other resources pertaining to jobs for hire. Once 18 months in transitional home are completed and beauty school state license is received single mother and children will be offered a full time independent living arrangement through donations to A Mother's Second Chance, where Mothers and children will live, work, and will be self-sufficient to be able to pay back a minimal rent to A Mother's Second Chance, with the income they will be receiving.

Over the course of the applicants' schooling they will be required to complete 200 hours apprenticing/donating their time to other Non-Profit 501C3 organizations within our community.

QUALIFICATIONS: This is a drug free work place and organization. Random drugs tests will be given. Background checks will be conducted, driving license report, proof of citizenship.

GED or high school diploma. Schools and applicants will provide report cards of tardiness, absent days and/or discipline. As a third party payee for these scholarships, it will be revoked if any of these mandatory guidelines are not met and third party payment to schools for funds will be terminated ending immediately and applicant will be responsible for the debt. (Down payment and monthly payments will be made on scheduled dates to schools by this organization's funding.)

One hour weekly "open topic" meetings, "supporting mothers' brunch" will be offered at no cost, as well as "lunch in the park" (on a weekend for play dates for children recognized within the mothers). It is mandatory to attend two (2) meetings a month to make sure everyone is healthy, happy and still confident in their new school and career. Any concerns will be addressed at that time. (Social worker or therapist will be hired to evaluate weekly meetings and any private sessions needed for these women).

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c)(3) section of the internal revenue code and are operated exclusively for educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which shall provide opportunities for involvement in said activities and programs in order to have a greater impact for change.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the marketing of distributions to organizations that qualify as exempt organizations described under section 501C3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 C3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

2.02 Powers

The corporation shall have the power, directly or indirectly, alone or in conjunction or cooperation with others, to do any and all lawful acts which may be necessary or convenient to affect the charitable purposes, for which the corporation is organized, and to aid or assist other organizations or persons whose activities further accomplish, foster, or attain such purposes. The powers of the corporation may include, but not be limited to, the acceptance of contributions from the public and private sectors, whether financial or in-kind contributions.

2.03 Nonprofit Status and Exempt Activities Limitation.
