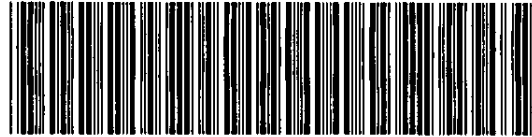

ARTICLE IX- Winding up and distribution of assets
