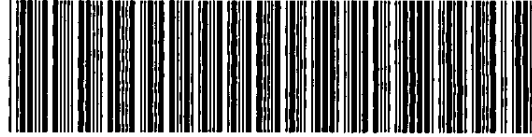

**ARTICLES OF INCORPORATION
OF
PEOPLE HELPING PEOPLE COMMUNITY DEVELOPMENT CORPORATION**

The undersigned, citizens of the United States, adopt the following Articles of Incorporation pursuant to the State of Florida Nonprofit Corporation Act.

- ONE: The name of the Corporation shall be People Helping People Community Development Corporation.
- TWO: The place in this state where the principal office of the Corporation is to be located is 4817 Rochdale Road, Jacksonville, FL, 32208, Duval County.
- THREE: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, to aid disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teen Pregnancy & Abstinence Programs, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elder Care and other programs that assist disadvantaged persons.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- FOUR: **The manner in which Directors are elected or appointed are:**

The qualification for membership and rights of the members shall be described in the By-Laws.

EIGHT: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
