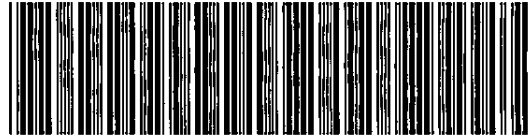

Program at South University, Royal Palm Beach, Fl.


