Article III: The specific purpose for which this corporation is organized is exclusively for charitable, religious, educational and scientific purposes, including for such purposes under Section 501(c) (3) of the Internal Revenue Code or corresponding sections of any future federal tax code. More specifically, the Basic Learning Skills Learning Center is to provide supplemental tutorial services in mathematics, language arts and related areas to promote education and defeat illiteracy. Our mission is to ensure that our students receive the greatest level of tutorial assistance that enable them to achieve success and perform competitively. Basic Learning Skills Learning Center will strive to support in such a manner as the Board of Directors determines charitable educational activities programs for students throughout the state of Florida. Thus, the Basic Learning Skills Learning Center is established to make distributions of equipment/tutorial services that qualify under section 501(c)(3) of the Internal Revenue Code to children or organizations, to create or participate in collaborative partnership programs for educating, training and mentoring; this includes collaborative relationships with schools, social agencies, health providers, community businesses, exceptional special education specialists, colleges and universities directly or indirectly to achieve the desired goals. In carrying out such purposes this Corporation shall have all the powers and authorities granted by statue and law, including the power to accept gifts, devices and other contributions for charitable purposes either directly or directly with other community agencies with common goals to help students learn with limited access, special needs and at-risk. Article IV: The Incorporator shall appoint the initial Board of Directors, thereafter, the Board shall choose its own members by majority vote as provided for in the by-laws. Article V: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, otherwise attempting to influence legislations, and the corporation shall not participate in, or intervene in (including the publishing
