

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617EFloridal particles of Incorporation:

ARTICLE I: NAME

ARTICLE V: LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617:0302, Florida Statutes, unless limited as follows:

The corporation shall be empowered to enter into contracts, hold and convey title to real and personal property, and exercise all powers permitted a corporation not for profit and the other laws of the state of Florida, not inconsistent with the general objectives enumerated herein.
