Articles of Incorporation

**Article 1 – Name**

The name of the corporation shall be the Bowls for Good Inc.

**Article 2 – Principal Office**

The Bowls for Good Inc. maintains its principal office at 2464 Australia Way East  
#64 Clearwater, FL 33763

**Article 3 - Purpose**

The purpose of the Bowls for Good Inc. (hereafter "BFG") is to promote and perpetuate the craft of wood turning through education and outreach and through such activities raise funds and engage in community service to combat hunger in the United States.

No part of the net earnings of the BFG shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the BFG shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes. The property of the BFG is irrevocably dedicated to promoting the craft of woodworking, in all its varieties, through education, outreach and community service and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the BFG shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the BFG shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate

for public office. Notwithstanding any other provision of these articles, the BFG shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the BFG.

Upon the dissolution of the BFG, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

#### **Article 4 – Manner of Election**

BFG directors, commencing with the expiration of the term of the Initial Directors, shall be elected by the members of the BFG at such time and in such manner as prescribed by the By-Laws.




