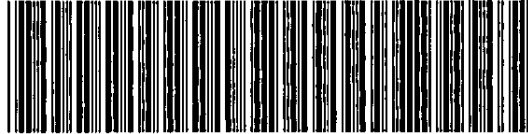

# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I:

The name of the corporation shall be **PYFA-Storm Inc.**

## ARTICLE II:

The principal street address shall be **1501 Massachusetts Ave., Lynn Haven, FL 32444.**

## ARTICLE III:

The purpose for which the corporation is organized is to foster the sport of football and regulate activities among the youth of Northwest Florida, and to educate adults to be youth leaders through involvement in the association of youth football.

This corporation shall continue forever unless the Officers and/or Directors terminate it and distribute all of the principal and income, which action may be taken by the Officers and/or Directors at any time. On such termination, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
