ARTICLE I NAME

The name of the Corporation shall be: **DILLARD HIGH SCHOOL ALUMNI BAND ASSOCIATION INC**

ARTICLE III: PURPOSE

The purpose of the Dillard High School Alumni Band Association Inc (DHS-ABA) is to fully support the efforts of the music and band program at Dillard High School located in Ft Lauderdale, FL, to provide a supportive, family environment for former band members to fellowship and celebrate the Dillard Marching Panthers' legacy, and to contribute to the holistic development of all band students by providing them with resources to become productive citizens.

Dillard High School Alumni Band Association Inc (DHS-ABA) is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV: MANNER OF ELECTION

Appointment of Officers: The President appoints the Board of Directors to fill the following positions: Vice-President, Secretary, Treasurer, and Sargent-at-Arms. The Board of Directors remain in office for the stated term duration unless interrupted by a terminating event (i.e. death, resignation, dismissal for improper conduct, etc). Vacancies arising due to a terminating event shall be filled temporarily at the discretion of the President until the next annual meeting.

Term of Office: The minimum tenure for the initial Board of Directors is two years. Terms of service after the initial period are subject to majority vote by paid members of the organization at annual meeting.

Removal from Office: A member(s) of the Board of Directors may be removed for just cause based on indisputable evidence by majority vote by the Board of Directors.
