ARTICLES OF INCORPORATION

OF

LITTLE GROVE NO. 1 CONDOMINIUM ASSOCIATION, INC.

THE UNDERSIGNED, hereby associate themselves for the purpose of forming and Corporation Not For Profit pursuant to Sections 718 and 617, Florida Statutes, and certify as follows:

ARTICLE I, NAME

The name of the corporation is Little Grove No. 1 Condominium Association, Inc., a Florida Corporation Not For Profit, hereinafter referred to as the "Corporation". The mailing address of this corporation is 8000 W. 24th Avenue, Bay 1, Hialeah, Florida 33012.

ARTICLE II. PURPOSE

The purpose for which the Corporation is organized is as follows:

- 1. The Corporation is to be the "Association" as defined in Section 718.111, Florida Statutes, for the operation of Little Grove No. 1 Condominium Association, Inc., a Condominium created pursuant to the provisions of the Condominium Act, Chapter 718, Florida Statutes.
- 2. The Corporation, as such Association, shall operate and administer said Condominium and carry out the functions and duties of said Condominium Association as set forth in the Declaration of Condominium for Little Grove No. 1 Condominium Association, Inc. and Exhibits annexed thereto establishing said Condominium.

ARTICLE III. POWERS

The powers of the Corporation shall be governed by the following provisions:

- 1. The Corporation shall have all the Common Law and Statutory Powers of a Corporation Not For Profit as set forth in Florida Statutes, Chapter 617, which are not in conflict with the terms of these Articles.
- 2. The Corporation shall have all the powers granted to the Corporation by Section 718.111, Florida Statutes, and as amended from time to time.
- 3. The Corporation shall have all the powers reasonably necessary to implement the purposes of the Association, and all of the powers granted to it in the Declaration of Condominium for Little Grove No. 1 Condominium Association, Inc., and Exhibits annexed thereto recorded in the Public Records of Miami-Dade County, Florida.
- 4. The Corporation shall have the power to contract for the maintenance, operation, and management of the Condominium Property, and delegate to such contractors all powers and duties

of the Association.

ARTICLE IV. MEMBERS OF CORPORATION

The qualification of members, the manner of their admission and voting by such members shall be as follows:

- 1. All Unit Owners shall be members of the Corporation and no other person or entities shall be entitled to membership. Such membership shall automatically terminate when such person is no longer the Unit Owner of a Condominium Parcel.
- 2. Subject to the foregoing, admission to and termination of membership shall be governed by the Declaration of Condominium for Little Grove No. 1 Condominium Association, Inc., that shall be filed in the Public Records of Miami-Dade County, Florida.
- 3. The share of a member in the funds and assets of the Corporation cannot be assigned, pledged, or transferred in any manner except as an appurtenance to the individual Condominium Unit.

ARTICLE V. DIRECTORS

- 1. The affairs and property of the Association shall be managed and governed by a Board of Administration composed of three (3) or more persons ("Directors") who shall be members of the Corporation, excepting that Directors appointed by the Developer need not be members of the Corporation.

- 2. Membership in the Corporation and the transfer thereof as well as the number of members and their voting rights shall be upon such terms and conditions as provided for in the Declaration of Condominium and the By-Laws.
