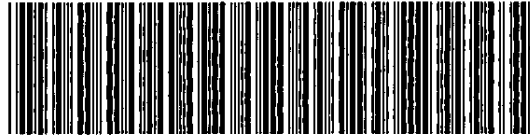

ARTICLE VIII. DISSOLUTION OF ASSETS

Upon termination or dissolution of The Foundation for Education and a Lifetime of Leadership through Art, Inc. any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization(s) have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization receiving the assets of The Foundation for Education and a Lifetime of Leadership through Art, Inc. shall be selected by the discretion of a majority of the managing body of The Foundation for Education and a Lifetime of Leadership through Art, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against The Foundation for Education and a Lifetime of Leadership through Art, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as to reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization(s) to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
