THE UNDERSIGNED, acting as incorporator, does hereby execute, acknowledges and file the following Articles of Incorporation for the purpose of creating a corporation not for profit under the Florida No For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes.


