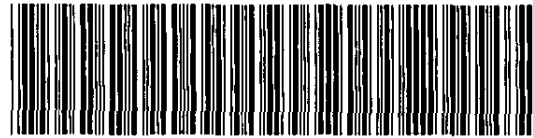

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

Thee Church of Jesus Christ, Inc. is organized exclusively for charitable, religious and educational purposes [within the meaning of 501(c) (3)] as a community development corporation. Thee Church of Jesus Christ, Inc.'s charitable and educational purpose is to offer charitable, religious, and educational community based programs for families in the North Florida are.

This organization is not organized for the private gain of any person. It is organized under the Non-Profit Charitable and Educational Law exclusively for religious, charitable, and educational purposes.

#### **ARTICLE VI SUPPLEMENTAL ARTICLES**

Said corporation (Thee Church of Jesus Christ, Inc.) is organized exclusively for charitable, religious and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person.

Upon dissolution, liquidation, and winding up of the corporation, the board of directors shall, after paying and/or making provision for the payment of all of the liabilities of the corporation, the corporation, shall dispose of all the assets exclusively for the purposes of the corporation in such manner, to such organization and/or organizations that are organized and operate exclusively for charitable, educational, religious, or scientific purposes, as shall at the time qualify as an exempt organization under Section

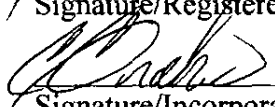
