





ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PENINSULA ON THE INTRACOASTAL CONDOMINIUM ASSOCIATION INC.

As used herein the following shall apply:

- A. Words in the text which are lined through with hyphens (---) indicate deletions from the present text.
 - B. Words in the text which are <u>underlined</u> indicate additions to the present text.
- 5. Section 5.2(i) of the Articles of Incorporation shall be amended to read as follows:
 - "5.2 Enumeration. The Association shall have all of the powers and duties set forth in the Act, except as limited by these Articles, By-Laws and the Declaration (to the extent that they are not in conflict with the Act), all of the powers and duties set forth in the Declaration and all of the powers and duties reasonably necessary to operate the Condominium pursuant to the Declaration and as more particularly described in the By-Laws, as they may be amended from time to time, including, but not limited to, the following:
 - (i) To enforce by legal means the provisions of the Act, the Declaration, these Articles, the By-Laws, and the rules and regulations governing the use of the Condominium Property and Association Property, but notwithstanding Section 5.2 to the contrary, the Association may but shall not be required to so enforce."
