**ARTICLES OF INCORPORATION
OF
FOREVER CHANGING MINDS INVOLVEMENT, INC.**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts and amends its Articles of Incorporation as follows:

ARTICLE I – NAME

The name of this corporation is **Forever Changing Minds Involvement, Inc.**

ARTICLE II – LOCATION AND MAILING ADDRESS

The principal place of business, which also serves as the business address is:

ARTICLE III – PURPOSE

FOREVER CHANGING MINDS INVOLVEMENT, INC. is organized for charitable, scientific, literary and education purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations within the meaning of the Internal Revenue Code or the corresponding section of any federal tax code.

Believing in the Individual, Reaching the Mind, and Teaching a New Way is the overarching purpose of Forever Changing Minds Involvement, Inc. This organization will give persons an opportunity to transition from an environment that caused them to commit crimes; provide a positive atmosphere for living, receiving an education, and job skills development; and assist with shelter and meals for women leaving prison. Such activities will cross all socio-economic statuses of prospective participants due to negative stigma associated with crimes. In addition to education, this organization will provide guidance and mentoring; social, psychological, physical health, well-being; and financial literacy support.

FOREVER CHANGING MINDS INVOLVEMENT, INC. shall provide either directly or by accepting donations, gifts, grants, contributions, guarantees, scholarships or fellowships, or subsidies to program participants and scholarship applicants according to the purposes for which it is organized; and engage in any activity permitted under the laws of the United States of America, its territories, districts, and possessions, and any activity permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not-for-profit by Chapter 617, Florida Statutes; and do all and everything necessary, suitable and proper, for the accomplishment of any of the purposes of the attainment of any of the objectives, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things.

incidental or appurtenant to or growing out of or connected with the aforesaid business of powers, or any part thereof; provided that the same be not inconsistent with the laws under which this corporation is organized.

The corporation will not discriminate against anyone on any basis under the law or as otherwise determined by the Board of Directors.

ARTICLE IV – CHARITABLE DISPOSITION

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE V – ELECTION AND APPOINTMENT OF DIRECTORS

This corporation shall have as directors those persons designated according to FOREVER CHANGING MINDS INVOLVEMENT, INC.'S By-Laws. The original officers and directors of this corporation are:

ARTICLE VI – DISSOLUTION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII – EFFECTIVE DATE OF ARTICLES OF INCORPORATION

The effective date for these articles of incorporation shall be the date of incorporation by the State of Florida.

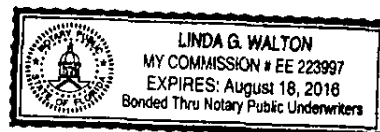
