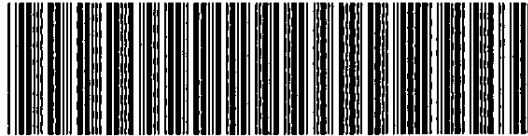

**ARTICLES OF INCORPORATION OF
FIRE AT THE ALTAR MINISTRY, INC.

We, the undersigned citizens of the United States, all of whom are of legal age, desiring to form a not for profit corporation under the Florida not for profit Corporation Act Chapter 617, Florida Statutes, certify and acknowledge the following

ARTICLE I: NAME – The name of this Corporation shall be: FIRE AT THE ALTAR MINISTRY, INC., with its principal place of business located 7215 Sheldon Road, Tampa Florida 33615

ARTICLE II: PURPOSE & PRIVILEGES – The general nature and object of this corporation is for the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father, to provide for Christian fellowship for those of like precious faith, where the Holy Spirit may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of spreading the gospel of Jesus Christ by all available means, both at home and in foreign land. We, whose names appear upon the roster of the FIRE AT THE ALTAR MINISTRY, INC.

As of the day of this signing, we do hereby recognize ourselves as a local assembly to equip, train, and activate the body of Christ to administer the gifts and talents given by God to advance the kingdom of God on earth as it is in heaven.

This corporation is further organized for the purpose of holding the title to such property or properties as the FIRE AT THE ALTAR MINISTRY, INC. shall from time to time purchase or acquire and it shall have power from time to time to make such contracts and do such things as shall be authorized and directed by its members. This assembly shall have the right to govern itself according to the standards of the New Testament Scriptures. Endeavoring to keep the unity of the Spirit in the bond of peace. Till we all come in the unity of the faith, and the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ. Ephesians 4:3 & 13

ARTICLE III: MEMBERSHIP – The members of the corporation shall be all members in good standing at any given time of said Church Corporation of Florida, provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his membership ceases in the aforesaid corporation. This corporation shall not have the power to buy, mortgage, sell, encumber or deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successor.

ARTICLE IV: TERM – This corporation shall exist perpetually or until dissolved by due process of the law.

ARTICLE VI: SUBSCRIBERS - The officers who are to manage the affairs of this corporation shall be as follows: A President, a Secretary, and a Treasurer, which three officers shall be the officers of the corporation, and such other officers, as shall be provided for in the Constitution and Bylaws, all of whom shall constitute and be the Official Board of Directors.

They shall be elected from time to time in accordance with the Constitution and Bylaws and each shall hold office until his successor is elected and ratified at its regular annual meeting. The President shall sign and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

ARTICLE VII: CONSTITUTION AND BYLAWS - This Corporation shall have the power to govern itself in accordance to its Constitution and Bylaws. The Constitution and Bylaws may be amended in the following manner; every amendment must first be approved by the Pastor and the Official Board of Directors. Then at a member's business meeting called for that purpose, be approved by two-thirds (2/3) vote of those present.
