Articles of Incorporation Of

Church of God Written in Heaven, Inc. (In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Church of God Written in Heaven, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 9431 Harriet Avenue, Jacksonville, FL 32208. The initial registered agent of the Corporation at such address shall be: Jaye A. Silver.

Article 8.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
