Articles of Amendment

FOUNDATION TURANDOO, INC.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows:

Section 1: Primary Purpose Foundation Uni. Ekologik is organized exclusively for charitable, religious, educational, & scientific purposes, including, but not limited to, the following:

- a. The promotion & development of ecological awareness, environmental conservation, & sustainable practices.
- b. The support of initiatives, programs, & projects aimed at preserving enhancing the natural environment, biodiversity, & ecosystems.
- c. The dissemination of knowledge & education related to ecology, environmental protection, & sustainable development.

Section 2: Support for Sustainability Initiatives Foundation Uni. Ekologik shall actively engage in activities that contribute to the achievement of it's primary purpose. This may include, but is not limited to, the following:

- a. Partnering with organizations, institutions, & individuals that share a commitment to ecological sustainability & environmental protection.
- b. Initiating & funding projects or research endeavors that align with the organization's mission & objectives.
- c. Advocating for policies & practices that promote sustainable development & mitigate environmental degradation.
- d. Training e. Event management, Green Communication, Marketing/Media, Training for adults & children, Business support, CSR: corporate social responsibility, Consulting, Strategies, development, implementing ecological frameworks policies & procedures with companies. Carbone Print, Airlines, Agriculture, apiculture, reforestations, Plantations, Ecologies, Aggrotech, permaculture, pharmacopeia, Plant Medicine, Indigenous healing, Aquatic pollution, aquatic area, Creation of wells/water, Childhood, school, education, teaching Ecological nutrition, Real estate, ecological construction, construction of ecovillages & green cities: Green transportation & logistics: ecolourism

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
