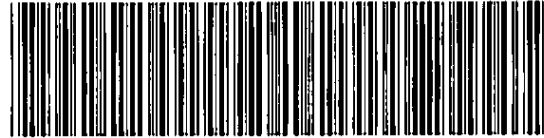

Pursuant to the provisions of §617.1403 of the Florida Not For Profit Corporation Act (the "Act") and for the purpose of effecting the dissolution (the "Dissolution") of USEPPA ISLAND WIRELESS NETWORK, INC., a Florida Not For Profit Corporation (the "Company"), the Company has adopted these articles of dissolution (the "Articles of Dissolution").

1. The name of the Company is USEPPA ISLAND WIRELESS NETWORK, INC., a Florida Not For Profit Corporation.

2. The Articles of Incorporation of the Company were filed on April 1, 2015 and assigned Document Number N15000003402.

3. The date of the meeting of the members at which the resolution to dissolve the Company was adopted on December 31, 2022. The number of votes cast by the members was sufficient for approval.

4. Other than cash, the Company no longer holds any assets and is not conducting any business; as such, the members of the Company desire to dissolve the Company.

5. All debts, obligations and liabilities of the Company have been paid or discharged.

6. There are no suits pending against the Company in any court.

7. Upon the filing of these Articles of Dissolution, the Company shall cease conducting its business and shall continue solely for the purpose of winding up its affairs in accordance with applicable provisions of the Act; and as soon as practically thereafter, all remaining assets of the Company will be distributed among the members without priority on a pro rata basis.
