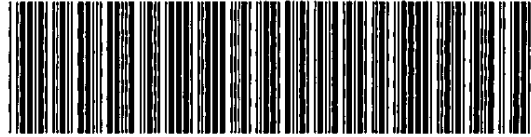



The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes.

Article I

Name, Street and Mailing Address

The name of the Corporation is "Citizens for a Safe Palm Beach County, Inc." The principal street and mailing address is: 708 Voyager Lane, North Palm Beach, FL 33408

Article II

Duration

The corporation shall have perpetual existence.

Article III

Purpose

The primary purpose for which this corporation is created and maintained shall be to conduct political activities as a political organization," including the support of and opposition to candidates for office and registering as a political committee, and to conduct one or more exempt functions under Section 527 of the Internal Revenue Code of 1986, as amended, and as permitted by the Florida Election Code.

Article IV

Registered Office and Agent

The street address of the initial registered office and the name of the initial registered agent is as follows:

Article V

Board of Directors

The corporation will have at least three Directors who shall be elected or appointed as provided in the bylaws; provided, however, that the incorporator will appoint the initial directors. The Board of Directors may authorize reimbursement of expenses incurred by Board Members in conjunction with the corporation's business or other approved activities directly related to the corporation's purpose.

Article VI

Incorporator

Article VII

Officers

The corporation may select the following officers to govern its day to day affairs: President, Secretary, Treasurer and/or Chairman and any other officers provided in the bylaws. An individual may hold more than one office in the corporation. Duties of Officers shall be described in the by-laws.

Article VIII

Indemnification of Officers and Directors

As provided in the bylaws, officers and directors shall be indemnified by the corporation against all expenses and liabilities, including attorney's fees, (including any incurred in appellate proceedings), reasonably incurred in connection with any proceeding or settlement thereof in which they may become involved by reason of holding such office. The corporation may purchase and maintain insurance on behalf of all officers and directors against any such liability asserted against them or incurred by them in their capacity as officers and directors or arising out of their status as such.

Article IX

Effective Date

These Articles of Incorporation shall become effective upon the filing and approval by the Secretary of State as indicated and may be amended in any manner consistent with Florida Law.

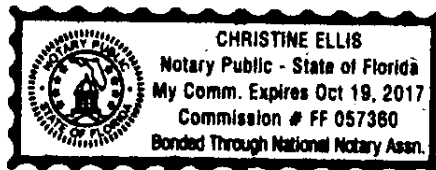
