

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Not for Profit Corporation Act, Chapter 617, Florida Statutes.

Article I

Name, Street and Mailing Address

The name of the Corporation is "Citizens for a Safe Palm Beach County, Inc." The principal street and mailing address is: 708 Voyager Lane, North Palm Beach, FL 33408

Article II

Duration

The corporation shall have perpetual existence.

Article III

Purpose
