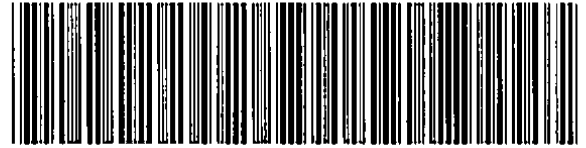



**Article II of the Articles of Incorporation of Thornton Creek Motorcoach Resort Owners Association, Inc. is hereby amended to read as follows:**

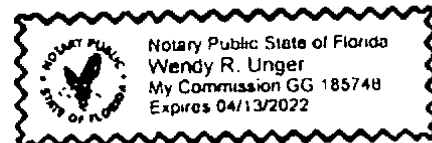


