ARTICLES OF AMENDMENT

The Trustees of LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC. hereby adopt the following Articles of Amendment for such corporation. The Original Articles of Incorporation were filed on APRIL 16, 2015 and were subsequently amended on June 24, 2016. Amendments to those Articles are hereby made as follows:

ARTICLE III

The purposes for which this corporation is organized are as follows:

To operate exclusively for religious, charitable, educational and distinct ecclesiastical Purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law thereto, and such purposes shall include the following:

- (a) To propagate among all people the Gospel of Jesus Christ based upon the precepts contained in the Holy Bible through the operation of its contents.
- (b) To provide support and counseling for families, and individuals.
- (c) To minister to the spiritual, emotional and physical needs of individuals and families with life controlling problems through Christian prayer and ministry.
- (d) To develop and support groups in various locations to offer these ministry services to other communities across the nation.
- (e) To develop and offer seminars and retreats that minister to the spiritual, emotional and physical needs of the individuals and families suffering with such needs.
- (f) To produce teaching materials that minister to the spiritual, emotional and physical needs of the individuals and families, including but not limited to books, CD's, DVD's, internet media and other communication media.

ARTICLE IX
501(c)(3) LANGUAGE

LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC., is not organized for pecuniary gain or profit, nor shall it have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any members, directors, trustees or individuals, except that LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC., shall be authorized and empowered to pay a reasonable compensation for services to employees who render services in furtherance of the purposes of the corporation. No substantial part of the activities of LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC., shall be the carrying on of propaganda or otherwise attempting to influence legislation, and, they shall not participate in or intervene in (including the publishing or distribution of statements) a political campaign.

Notwithstanding any other provisions of these articles, LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC, shall not carry on any other activities not permitted to be carried on by:


(a) A corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law or,

(b) A corporation, contributions to which are deductible under Sections 170 (c) (2) and 509 (a) (1) of the Internal revenue code of 1986, or the corresponding provision of any future United States Internal Revenue law.

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all of the business, property and assets of the corporation shall go and be distributed to such non-profit corporation qualifying as a organization exempt under the provisions of Section 501 (c) (3) and 170 of the Internal Revenue Code of 1986, or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose, as the directors or trustees of the corporation may select and designate; and in no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated or contributed by such members, or for any other such purpose. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the corporation is located, exclusively for such purposes, or the organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

These amendments were adopted at a duly organized meeting of the members of LIVING EMOTIONALLY FREE FOUNDATION LEFF, INC. and the number of votes cast for the amendments was sufficient for approval.
