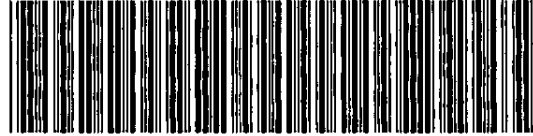





Articles of Incorporation - Addendum
Rx View Next Generation, Inc.

ARTICLE VIII – DISSOLUTION OF THE ORGANIZATION

- a. Rx View Next Generation, Inc. is organized exclusively to provide an array of health and wellness information to youth and young adults, through workshops, trainings, seminars, and support services. Programs, activities and services are designed to target health and social topics that impact youth and young adults including, but not limited to nutrition and health; exercise and fitness; mental health; sexually transmitted diseases; obesity and diabetes; and substance abuse. Programs, services, and activities may include support from, receipt of, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal revenue code, or corresponding section of any future federal tax code.
- b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall include the distribution of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office. Notwithstanding any other provision of this document, Rx View Next Generation, Inc. shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal revenue code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 107 (c) (2) of the Internal revenue code, or corresponding section of any future federal tax code.
- c. Upon the dissolution of Rx View Next Generation, Inc., funds shall be: 1) distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code; or corresponding section of any future federal tax code; 2) returned to grantors of grant funds; 3) returned to donors and/or contributors; 4) used to pay any outstanding employee salaries and/or payroll taxes; 5) used to pay outstanding account's payables to vendors and creditors; 6) distributed to the federal government; 7) and/or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Leon County in which the principal office of the organization is then located; exclusively for such purposes; or to such organization or organizations; as said Court shall determine which are organized and operated exclusively for such purposes.
