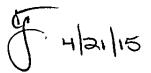

Articles of Incorporation of Environmental Cause Corporation

ARTICLES OF INCORPORATION OF ENVIRONMENTAL CAUSE CORPORATION The undersigned natural persons of the age of eighteen (18) years or more, hereby establish a non-profit corporation under the laws of the State of Florida, as contained in Florida Not For Profit Corporation Act contained in Chapter 617 of the Florida Statutes and the several amendments thereto, and to that end do hereby set forth:

Article I.

The name of the non-profit corporation is the Environmental Cause Corporation.

Article II.

The period of duration of the corporation shall be perpetual.

Article III.

The place in this state where the principal office of the Corporation is to be located is 1204 East Cumberland Ave. #418, Tampa, FL 33602 (Mail: P.O. Box 25712 Tampa, FL

The initial registered agent for the corporation is: Myra R. Cause.

Article IV.

The names and addresses of the incorporators are:

Article V.

The purposes for which the corporation is organized are:

- (1) To conduct public and private education and discussion groups, forums, panels, lectures, consulting, or other similar programs regarding environmental topics;
- (2) To instruct the public on subjects useful to individuals and beneficial to the community;
- (3) Notwithstanding any other provisions of this document, the organization is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 2014, and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under IRC 501(c)(3) or corresponding provisions of any subsequent tax laws.

Article VI.

This corporation shall be a non-profit corporation pursuant to Chapter 617 Florida Not For Profit Corporation Act of the Florida Statutes, with the following additional purposes and powers:

- (a) To enter into any and all forms of contract documents and agreements and to conduct education, information, and referral services;
- (b) To conduct its affairs, carry on its operations, and adopt policies and procedures for the furtherance of the affairs of the corporation and to promote the common business interest of the members.
- (c) To have and exercise all other powers necessary or convenient to effect any or all of the purposes for which the corporation is organized;
- (d) To exercise all general powers provided in Chapter 617 Florida Not For Profit Corporation Act of the Florida Statutes;
- (e) To assume all powers granted to a non-profit corporation by the laws of the State of Florida;
- (f) To assume all powers granted to a non-profit corporation by the laws of the United States.

Article VII.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. No part of the net earnings of the corporation shall inure to the benefit of any private member or individual or corporation, either during its existence or in the event of its dissolution.

Article VIII.

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX.

The affairs of the corporation shall be managed by a Board of Directors, elected by the incorporator and the Board of Directors shall select officers as the Board of Directors may deem proper.

Such Board of Directors shall not be less than three (3) and may be in such larger as determined by the Board of Directors. The officers shall complete power and authority to act for and on behalf of the corporation in all transactions and matters within the power and objects of the corporation or incident thereto.

Article X.

The Board of Directors shall select the date of the first and succeeding annual meetings of the corporation.

The initial Board of Directors shall make and adopt Bylaws for the corporation and said Board and its successors in office shall have the power to alter, amend, and rescind such Bylaws and adopt new Bylaws.
