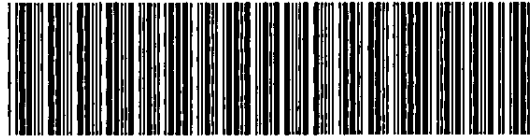



In order to form a corporation under and in accordance with the provisions of Chapter 617, Florida Statutes, the undersigned subscriber is a natural person and competent to contract and hereby make, adopt and subscribe the following Articles of Incorporation, to-wit:

ARTICLE I
Name of the Corporation

The name of the Corporation shall be SOS-BS Org, Inc., hereinafter referred to as the "Organization".

ARTICLE II
Address of Principal Office

The mailing address and principal office of the Organization is 9865 N.W. 25th Terrace, Doral, FL 33172.

ARTICLE III
Purpose of the Organization

For any and all charitable purpose(s) serving members of the community who are deprived of same.

ARTICLE IV
Board of Directors

ARTICLE VI
Initial Registered Agent and Registered Office

ARTICLE VIII
Term of Existence

The Organization shall commence existence upon the filing of these Articles of Incorporation with the Department of the State of Florida. The term for which this Organization shall exist shall be in perpetuity, unless lawfully dissolved according to law.

ARTICLE IX
Amendment

These articles may be amended, altered or repealed in accordance with the laws of the State of Florida and by the By-Laws of this Organization shall be made, altered or rescinded by a two-thirds vote of the directors present at any regular or special meeting called for the purpose of a change or amendment thereto according to law.

ARTICLE X
By-Laws

The initial Board of Directors of the Organization shall adopt By-Laws consistent with these Articles of Incorporation. Thereafter, the By-Laws may be altered or rescinded by the directors in the manner provided for by such By-Laws. Pursuant to Section 617.0202(d), Florida Statutes, the method of election of directors is as stated in the bylaws. ARTICLE XI
Prohibitions

Notwithstanding any other provision of these Articles, the Organization shall not participate in any activities not permitted to be carried on (a) by an Organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an Organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE XII
Liabilities for Debts

Neither the members nor the members of the Board of Directors or officers of the Organization shall be liable for the debts of the Organization.

Having been named as registered agent to accept service of process for the above stated non-profit organization at the place designated in this capacity. I further agree to comply with the provisions of all statutes, relating to the proper and complete performance of duties, and I am familiar with and accept the obligations of my position as registered agent.
