ARTICLES OF INCORPORATION OF HOPE YOU CAN HOLD, INC.

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I - NAME: The name of the Corporation shall be Hope You Can Hold, Inc.

Article II - PRINCIPAL OFFICE: The place in this state where the principal office of the Corporation is to be located is 409 Tangerine Drive, in the City of Oldsmar, Pinellas County, Florida 34677.

Article III - PURPOSE: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose for which the corporation is organized is to coordinate, create, and distribute bead necklaces to cancer, multiple sclerosis, and amyotrophic lateral sclerosis patients.

Article IV - MANNER OF ELECTION: The Board will fill any vacancy within 60 (sixty) days of the effective date of the vacancy by a majority vote of the Board. The Board may elect to increase the number of directors on the Board as needed, but the total positions must always be an odd number. Removal of any Board member requires a super majority vote of the Board.

Article VI - 501(c)(3) COMPLIANCE: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue

Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII - DISSOLUTION AND ASSETS: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. The final distribution of assets shall only be to exempt organizations under section 501(c)(3) of the Internal Revenue Code whose primary purposes are to aid cancer, multiple sclerosis, and amyotrophic lateral sclerosis patients or aid the research of cancer, multiple sclerosis, and amyotrophic lateral sclerosis.




