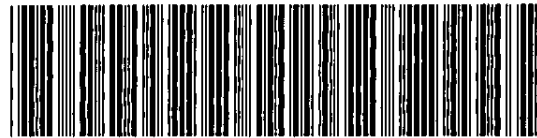

The undersigned incorporator being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be **THE L.Y.N. FUND, INC.**

ARTICLE II

This corporation shall be a not for profit corporation pursuant to Chapter 617, Florida Statutes.

ARTICLE III

The street address of the initial principal office of this corporation is 2811 Spring Oak Court, Palm Harbor, Florida 34684.

ARTICLE IV

The purpose for which the corporation is organized is to raise and disburse funds and otherwise engage in all related activities which will promote and facilitate assisting cancer patients with living expenses while in active treatment. This will allow them to focus on healing and raising their families instead of on financial distress.

ARTICLE V

The method of election of directors of the corporation shall be stated in the By-Laws.

ARTICLE VI

There are no limitations on the corporate powers authorized under Chapter 617, Florida Statutes.

ARTICLE VII
