ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of this corporation shall be WALKING THROUGH WATERS MINISTRY, INC

ARTICLE II DURATION

The period of duration of the corporation is perpetual unless dissolved according the law.

ARTICLE III PURPOSE

The corporation is organized and shall operate exclusively for educational, religious and charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

WALKING THROUGH WATERS MINISTRY, INC is an organization with a missionary heart to expand and multiply the faith in Jesus Christ, including, but not limited the development of Christian Ministries for children, youth, couples, family in the United States and abroad. Also support and supply with christian materials such as bibles, books, manuals etc. to the most disadvantages communities, churches around the world. To engage in any other activity not prohibited to corporations under the Florida Not-For-Profit Corporation Act that is in furtherance of section 501©(3) tax-exempt purposes.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for educational, religious and charitable purposes.

ARTICLE IV PRINCIPAL OFFICE

The principal street address is 842 SW 14 APT 1, MIAMI, FL 33135-5262. The mailing address is the same.

ARTICLE V MANNER OF ELECTION

The corporation shall not have members. The affairs of the corporation shall be conducted by the board of directors of the corporation. The method of election of directors shall be stated in the Bylaws of the corporation.

ARTICLE VI LIMITATIONS

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of WALKING THROUGH WATERS MINISTRY, INC of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VIII DEDICATION OF ASSETS

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
