ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR

THE CANCER SOCIETY OF THE BAHAMAS FOUNDATION, INC.

(A Florida Not For Profit Corporation)

The undersigned, for the purposes of amending the Articles of Incorporation as filed with the Florida Department of State, Office of the Secretary of State, pursuant to the Florida Not for Profit Corporation Act (the "Act") and the Bylaws of The Cancer Society of the Bahamas Foundation, Inc. (the "Corporation"), hereby adopts the following Articles of Amendment to the Articles of Incorporation for the corporation:

ARTICLE VII

Board of Directors

This Corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by amendment to the Bylaws but shall never be less than three (3).
