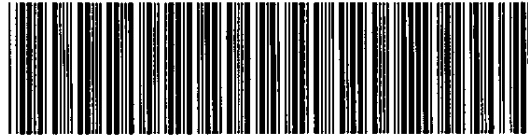

**ARTICLES OF INCORPORATION  
OF

The undersigned Incorporator of Douglas G. Robinson Perseverance Pancreatic Cancer & Empowerment Foundation, a Florida corporation, adopts the following Articles of Incorporation:

**ARTICLE I  
Name**

The name of the corporation is Douglas G. Robinson Perseverance Pancreatic Cancer & Empowerment Foundation, Incorporated.

**ARTICLE II  
Term of Existence**

The term of existence shall be perpetual.

**ARTICLE III

**ARTICLE IV  
Purpose**

The Corporation is organized as a Florida not-for-profit corporation established exclusively for charitable, educational, and scientific purposes including the power to provide services to advance the nonprofit sector through education, consultation, advocacy, publication, and such other activities as benefit the nonprofit sector. The Corporation shall operate in furtherance of such other purposes, causes, and objects as would qualify for federal tax exempt status under Section 501(c)(3) of the Internal Revenue Code, as amended (the "Code"). In pursuance of such other purposes, causes, or objects, the Board of Directors shall have the power, without limitation, to make distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code and as public charities under Section 509(a)(1) or (2) of the Code.

Notwithstanding any provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code including but not limited to:

The corporation has the power to engage in any lawful activity under the corporation code of the State of Florida, including opening and operating a bank account.

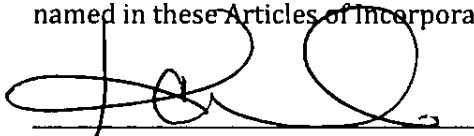

## **ARTICLE IX**

### **Bylaws**

The incorporator shall adopt the initial bylaws of the corporation. The Board may amend the bylaws at anytime by the provisions therein.

## **ARTICLE X**

### **DIRECTORS**

**FUNCTION AND POWERS.** The business and affairs of the Corporation shall be managed by its Board of Directors, including control of management of the property of the Corporation. All corporate powers will be exercised by or under the authority of the Board of Directors.

**QUALIFICATION.** Directors must be natural persons who are 18 years of age or older but need not be residents of Florida.

### **ELECTION AND TERM.**

- a. Initial Board. Each person named in the Articles of Incorporation as a member of the Board of Directors will hold office until the Initial meeting of the Board of Directors or a Special Call Meeting is held and until such person's successor is elected and qualified or until such person's earlier resignation, removal from office, or death.
- b. Annual Election of Board. At each annual meeting of the Board of Directors, the incumbent Board of Directors will elect a successor Board of Directors by plurality vote. Each director so elected will hold office until the next succeeding annual meeting and until such director's successor has been elected and qualified or until such director's earlier resignation, removal from office, or death.
- c. Election of Chair of Board. The Board may elect a Chair, and if one is elected, the Chair will preside at all meetings of the directors and will have such duties as may from time to time be prescribed by the Board of Directors.
- d. Quorum and Voting. A majority of the number of directors prescribed by these Bylaws constitutes a quorum for the transaction of business. If a quorum is present when a vote is taken, the affirmative vote of a majority of directors present is an act of the Board of Directors.

## **ARTICLE XI**

### **Dissolution**

Upon such dissolution or winding up of the affairs of the Corporation, whether voluntary or involuntary, the assets of the Corporation, after all debts have been satisfied, then remaining in the hands of the Board of Directors shall be distributed, transferred, conveyed, delivered, and paid over, in such amounts as the Board of Directors may determine or as may be determined by a court of competent jurisdiction, exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, and its regulations as they now exist or as they may hereafter be amended, PROVIDED, HOWEVER, that any distributions upon dissolution of this Corporation shall be to and for the exempt purposes of this Corporation as enumerated in the Articles of Incorporation of this Corporation.

**ARTICLE XII**  
**Indemnification**

The corporation does indemnify any directors, officers, employees, incorporators, and shareholders of the corporation from any liability regarding the corporation and the business of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable state corporate statute.
