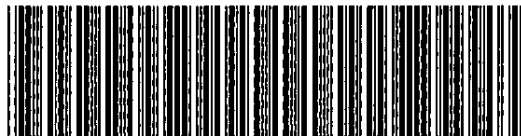

By the Articles of Incorporation Pursuant to the provisions of Florida Nonprofit Articles of Incorporation In Compliance with Chapter 617, F.S., (Not for Profit) of the Florida Statutes, Florida General Corporation Act, the incorporator forms a not-for-profit foundation under Florida Law.

Article I. Name

Article III. Existence

The date on which official corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of the State of Florida.

3.01 Duration

The corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida.

3.02 Membership

This Corporation shall have no members. The management of the affairs of the corporation shall be vested in a board of directors, as defined in the corporation's bylaws.

Article IV. Mission and Vision

Mission: DMB Missionary Resources Foundation, Inc. has a Charitable, Christian Ministry that provides faith based outreach services to missionaries and their families via financial grants, other charitable services and methods.

Vision: Our vision is for a network of support systems for active missionaries and those returning from the mission field, particularly in the USA and the Caribbean, area, but also around the world. Our outreach services will focus on the personal, marital, psychosocial, educational, spiritual, and family life of the missionaries who are - Soldiers in the Lord's Army.

Values: DMB Missionary Resources Foundation, Inc. will invest in missionaries by providing a variety of services that focus on the basic personal, marital, and family life needs of the missionary. These services include but are not limited to hospitality, housing, transportation, medical and dental care, referrals, retreats, training, scholarships, and religious services.

Article V. Purpose

5.01 Public Benefit

DMB Missionary Resources Foundation, Inc. corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of grant distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors, officers, members, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes.

Except as otherwise provided by Section 501(h) of the Code, no substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation.

The corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code, or (b) by a corporation contributions to which are deductible under Section 170(a) of the Code as being to an organization referred to in Section 170(c)(2) of the Code.

5.02 Non-profit Nature

DMB Missionary Resources Foundation, Inc. is a faith based, charitable, not for profit, religious, voluntary, public benefit corporation, organized exclusively

for charitable, religious, educational, literary, and scientific purposes. Including, for such purposes, a dedication to helping missionaries and their families, in the USA, the Caribbean, and worldwide, to navigate life's difficulties both socially and financially.

DMB Missionary Resources Foundation, Inc. will interact with other governmental, state, county, faith based and community based organizations, churches and other missionary resource organizations to enhance community outreach programs, to provide services such as housing, seminars, conferences, peer support, and other educational programs, and religious programs, to those in need spiritually, socially and financially. This will include but will not be limited to referral services for missionaries returning from the field, those who are retiring, and their families, schools and churches in the USA, the Caribbean and worldwide.

To raise awareness, and enlist the public's help in supporting missionaries.

To provide direct programs and services to meet the needs of missionaries and their families, by providing financial scholarships to educationally, gifted children of missionaries in the USA and worldwide.

To provide an interactive internet website that will provide for missionaries, both financially, spiritually and physically. Also to provide missionary and churches with support to help their work in the field.

To provide educational scholarships and awareness workshops, seminars, conferences, and other awareness programs while facilitating discussion and peer support groups via face to face, conference line support or via live chat on the Internet.

The DMB Missionary Resources Foundation, Inc. exists to provide, enlist, and coordinate resources that will enhance the health, longevity of service, and ministry effectiveness of missionaries and their families, in order to promote the effective spread of the Gospel. To provide missionaries with practical

Communication and logistic support to facilitate efficient access to provisions donated, and provided by the church, general public and corporate sectors.

- (a) Limit the purposes of such organization to one or more exempt purposes Under IRC 501(c) (3);
- (b) Not expressly empower the corporation to engage, otherwise than as an insubstantial part of its activities that in themselves are not in the furtherance of one or more exempt purposes; and (c) Provide that an Organization's assets must be dedicated to an exempt purpose within IRC 501(c) (3). Either by an express provision in its governing instrument or by operation of Law; and the written Bylaws of DMB Missionary Resources Foundation, Inc.
- (d) The corporation may acquire, receive, take and hold by bequest, device, grant, gift, purchase, exchange, lease, transfer, judicial order or decree, or otherwise, for any of its objects and purposes, any property, both real and personal, of whatever kind, nature of description and where ever situated.
- (e) To sell, exchange, convey, mortgage, lease transfer or otherwise dispose or any such property both real and personal as the objects and purpose of the Corporation may require, subject to such limitations as may be prescribed by Law.
- (f) The, DMB Missionary Resources Foundation, Inc. operations are to be conducted principally in the United States of America; the Corporation may, also conduct operations in foreign countries, subject however to the law of the State of Florida.
 - A.) Further services include but are not limited to hospitality, permanent and temporary housing, referrals, respite retreats, training, scholarships and religious services and chaplain services.
 - B.) To take, manage, hold and dispose of the property, real and personal, of said Corporation and to exercise any and all other rights and powers not in conflict with Chapter 617 of the Florida Statutes.

C.) To develop and administer programs designed to carry out the activities of the Corporation.

D.) To receive, administer, disburse and invest gifts, devises and bequests by and from any persons or corporations or entities and to operate as a not-for-profit organization in compliance with the Laws of the State of Florida and Section 501 (A) and Section 501(c) (3) of the Internal Revenue Code of the. United States of America.

E.) To have and to exercise to the extent necessary or desirable for the accomplishment of any of the aforesaid purposes, and to the extent that they are not inconsistent with the charitable purposes of the Corporation, any and all powers conferred upon non-stock corporations by the Florida General Corporation law.

5.03 Property

The property of the corporation is irrevocably dedicated to its religious, educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual.

5.04 Prohibited Distributions

1. This Corporation shall issue no stock. No part of the net earnings of this Corporation shall inure to the benefit of or be distributable to is directors, officers or other private persons except that this Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article.

5.05 Restricted Activities

2. No substantial part of the activities of this Corporation shall be the carrying on of or propaganda for or otherwise attempting to influence legislation, (except as otherwise provided in subsection (h)), and which does not participate in, or

(c) (2) of the Internal Revenue Law Tax Code or 1986

This Corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.

5.06 Prohibited Activities

3. Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This corporation shall have no capital stock and shall not engage in business for profit, but shall be supported by gifts, bequests, benefits, and contributions and donations. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

The corporation will from time to time make charitable distributions to other organizations with similar mission, that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Article VI. Manner of Election

Article VII. Executive Director

The Corporation shall have at least one Executive Director who may be the Founder of the corporation, and will be governed by the Bylaws of the corporation just like any other Board member. The number of other directors may be increased or decreased but will never be less than three directors at any given time during the legal lifetime of this not-for profit Corporation, based on the Florida non-profit statutes and the Corporation Bylaws.

Article VIII. Board of Directors

8.01. Governance

The **Governing Authority** shall be known as the Board of Directors, and shall have plenary powers to do all things necessary and proper to operate DMB Missionary Resources Foundation, Inc. in accordance with the stated purpose, tenets, goals and mission statement of the corporation per the corporation stated Bylaws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. No member or Director shall have any right, title, or interest in or to any property of the corporation.

8.02. Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of DMB Missionary Resources Foundation, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation, except to

Article VIV. Initial Directors and/or Officers

Article X. Officers Titles

All officers of this corporation will be volunteers of at least 18 years old. The offices of this corporation shall consist of at least four (4) official titles – President,

Vice-President, Secretary, Treasurer, and shall be selected by the Board of Directors at the Biannual meeting, at the commencement of each Biannual, to carry on the business of the Board for the period of two years. Board members serving as officers do not forfeit their voting rights.

Article XI. Board of Director Meetings

Regular meetings of the Board of Directors shall be held at times and places established by the Board of Directors and shall be held at least biannually. Advance notice of the date, time, place or purpose of these meetings is required.

Article XII. Corporation's Property

The real property of this not for profit corporation is irrevocably dedicated to charitable outreach ministry, and educational outreach, residential housing outreach, and other Christian Ministry, community outreach purposes. No part of the net income or assets of this non-profit corporation shall ever inure the private benefit of any directors, officers or board members thereof, or to the benefit of any private individual.

Article XIII. Dissolution

Upon the dissolution, termination, or winding up of DMB Missionary Resources Foundation, Inc. after payment of or making provisions for all costs and expenses of dissolution and all liabilities and obligations of this corporation, the remaining assets of this corporation will be distributed as determined by the Board of Directors, provided, however, that the remaining corporation assets shall be distributed to Pioneer Community Church, Inc. for continuation of the 501(c)(3) charitable, religious, and educational purposes, including, for such purposes as designated charitable, Christian missionary outreach, educational scholarship fund to high school seniors or graduates in the USA, the Caribbean, and the rest of the world, religious, or faith based instruction, counseling support, missionary housing accommodations for returning and retired missionaries, their widows, and their families, and psycho-social and awareness programs, within the

meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Any such assets not so disposed of by distribution to Pioneer Community Church, Inc. a charitable, Christian Church Ministry, known to have a charitable purpose, which, at least generally, includes a purpose similar to the mission of this corporation, described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) The organization to receive the assets of the DMB Missionary Resources Foundation, Inc. hereunder has been selected by the discretion of a majority of the initial managing body of the DMB Missionary Resources Foundation, Inc.

If in the future the managing directors no longer so agree, then a new recipient organization shall be selected pursuant to a verified vote of the current managing board of DMB Missionary Resources Foundation, Inc. If not, the court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

Article XIV. Amendments

This Corporation reserves the right to amend, alter, modify, or repeal any provision contained in these Articles of Incorporation, any amendment hereto in the manner now or hereafter prescribed by the State of Florida, and any rights and powers conferred upon the Directors and Board of Advisors herein is granted subject to this revision and the rules set forth in the Corporation Bylaws.

These Articles of Incorporation may be amended as follows: **(A)** At any regular or special meeting of the board of this Corporation, at which a quorum is present, by affirmative vote two-thirds of the members present and voting, providing the Board of Directors have previously considered the merits of the amendments. **(B)** No amendment shall be put to a vote unless written notice thereof stating the proposed amendment shall have been given to each director, by mail or personal delivery, at least two weeks prior to the meeting at which the vote on the proposed amendment is to be taken.

Any Amendment to the Articles of Incorporation may be adopted by approval of a majority vote of the board of directors.

Article XV. Indemnification
