Articles of Incorporation Of

Sedrick M. Irvin Loves Everybody, Inc. (In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Sedrick M. Irvin Loves Everybody, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 10402 SW 224th Ter, Miami, FL 33190. The initial registered agent of the Corporation at such address shall be: Sedrick Irvin.

Article 3.
