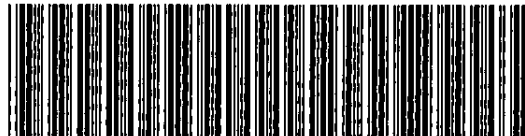

DISSOLUTION CLAUSE
